Most Important Notice

All First Year B. Tech students are hereby informed that Dr. Babasaheb Ambedkar Technological University (DBATU) has issued a circular demanding implementation of the revised promotion criteria from Academic Year 2025–26 onwards, applicable to Students admitted from A Y 2025-26, as per the University Ordinance applicable to undergraduate programmes.

The said matter was discussed in the Academic Council Meeting of the Institute held on 17th January 2026. During the deliberations, the honorable members of the Academic Council observed that immediate implementation from Academic Year 2025–26 may affect the academic progression of existing batches.

Accordingly, the Institute has proposed implementing the revised promotion criteria from Academic Year 2026–27 onwards to ensure adequate academic transition and student preparedness. In this regard, the Institute has formally communicated with DBATU seeking approval for phased implementation from Academic Year 2026–27 onwards.

Revised Promotion Criteria (as per DBATU Ordinance)

(by DBATU from A.Y. 2025–26 onwards; Proposed by Institute from A.Y. 2026–27 onwards)

A) Regular Entry – B. Tech (UG)

Promotion	Minimum Requirement
1st → 2nd Year	Minimum 85% of total credits of 1st year
2nd → 3rd Year	Minimum 85% of total credits of 2nd year and 1st year must be fully cleared
3rd → 4th Year	Minimum 85% of total credits of 3rd year and 1st & 2nd years must be fully cleared

B) Lateral Entry – B. Tech

Promotion	Minimum Requirement
2nd → 3rd Year	Minimum 85% of total credits of 2nd year
3rd → 4th Year	Minimum 85% of total credits of 3rd year and 2nd year must be fully cleared


