1. Introduction

SITCOE has initiated several schemes to promote academic and research activities. The aim of this initiative is to provide predictable benefits based upon achieving specific measurable quality-based outcomes. They are:

1. Grants

-Conference grant, travel grant.

2. Incentives and Benefits

-Cash Incentives, Leave Benefits.

2. Conference

SITCOE is committed to increase the exposure of its staff by encouraging them to attend & present papers in national and international conferences and to attend seminars/workshops for their professional growth, academic interaction and excellence in research. Following policy is made:

2.1 Financial Support:

It includes registration fees for attending conferences. For the all conferences in 100%registration fees will be given.

2.2 Leave Benefits:

Faculty can avail on duty (OD) leave maximum 8 days for international travel or maximum 5 days for national travel during teaching period per academic year.

2.3 Terms & conditions:

- 1) Affiliation for conference paper must be Sharad Institute of Technology College of Engineering, Yadrav.
 - 2) Financial support will be given only for First author.
 - 3) Faculty can avail this benefit maximum Two times in an academic year.

4) Only Conference proceedings (full paper) of IEEE / ACM / Springer / Elsevier / AIP etc. indexed in Scopus/WoS will be considered.

3. Journals

3.1 Incentives

The following incentives will be given to faculty members for publishing journal articles in mentioned categories

| Journal group | Incentive (Rs.) |
|---------------|-----------------|
| Q1 | 40,000/- |
| Q2 | 30,000/- |
| Q3 | 20,000/- |
| Q4 | 10,000/- |

3.2 Terms & conditions

- 1) Journal must have transparent and rigorous peer review method.
- 2) Each semester, one publication from a specific journal will received this benefit, with a maximum of two publications in each academic year.
- 3) Affiliation for article must be Sharad Institute of Technology College of Engineering, Yadrav.
- 4) If all authors are from SITCOE, Yadrav incentive will be given to First author only (Authors can decide mutually about distribution of incentive).
 - 5) For collaborative research criteria's are as follows

| 1st Author is from SITCOE, Yadrav | 100 % incentives as per journal group |
|---|---------------------------------------|
| 2 nd Author is from SITCOE, Yadrav | 50 % incentives as per journal group |
| 3 rd Author is from SITCOE, Yadrav | 25 % incentives as per journal group |
| 4th & onwards is from SITCOE, Yadrav | 15 % incentives as per journal group |

- 6) Faculty can avail this benefit maximum Two* times in an academic year.
- 7) No Article Processing Charges (APC) will be given.
- 8) Journal groups will be considered as follows
 - Q1-75 and above percentile from SCOPUS source database.
 - O2 51 to 74 percentiles from SCOPUS source database.
 - Q3 26 to 50 percentiles from SCOPUS source database.
 - O4 1 to 25 percentile from SCOPUS source database.

Terms & conditions

- 1) Affiliation for book/book chapter must be Sharad Institute of Technology College of Engineering, Yadrav.
 - 2) Faculty can avail this benefit maximum twotimes in an academic year.
- 3) Book chapter must be SCOPUS indexed and for book publication list of publishers is attached.
- 4) For collaborative publication, similar incentive percentage table will be followed as journal.

5. Intellectual Property Rights (IPR) Policy

- This Intellectual Property Rights policy is applicable to all the faculty, staff, students and researchers of SITCOE, Yadrav and others related to SITCOE, Yadrav.
- SITCOE, Yadrav shall be the sole owner as application done as per general interpretation of IP and the concerned SITCOE, Yadrav Personnel who created the IP shall be the inventors.
 - Any intellectual property that is made or designed or created by SITCOE, Yadrav personnel during their tenure of employment, research work or study or any other engagement/association at/with SITCOE and /or with use of SITCOE resources including but not limited to funds, time, facilities, equipment, manpower or any other resources.
 - It has been developed under any contractor tie-up or arrangement or work for hire or adhoc, or outsourced by SITCOE.
 - It has been developed with the use of external funds / facilities, including that of sponsored research or consultancy projects obtained in the name of or through SITCOE with or without any support or resource of SITCOE otherwise.
 - It has been developed pursuant to an agreement/collaboration/arrangement where ownership has been specifically transferred with SITCOE.

- Any IP also including Software, technology, process etc. developed over a period of time with/through contribution of SITCOE personnel for SITCOE.
- SITCOE, Yadrav shall share the ownership as applicant
 - If the IP is a result of funds sponsored by an organization, other than SITCOE, then
 the IP will be shared between SITCOE and the sponsoring agency on case to case
 basis, as per mutual agreement between SITCOE and the concerned organization.
 - When the IP has emerged as a result of an institutional/Industrial/any other consultancy, given by SITCOE, then the concerned organization and SITCOE shall jointly own the IP as per mutual agreement.
 - When the IP has emerged as a result of collaborative research work by SITCOE and other collaborating organization without external funding from third party, the concerned collaborating organization and SITCOE shall jointly own the IP as per mutual agreement.
 - If the IP has emerged as a result of collaborative research work by SITCOE and collaborating organization with support from external funding from third party, the concerned collaborating organization, sponsoring third party and SITCOE shall jointly own the IP as per mutual agreement.
 - When the IP has emerged out of the work carried out by SITCOE personnel during their visit to a third party/Institution/organization then it will be owned according to the terms and conditions defined in mutual agreement.
